## North Carolina General Statute N.C.G.S 115C-150.5-.8 (Article 9B)

Academically or intellectually gifted (AIG) students perform or show the potential to perform at substantially high levels of accomplishment when compared with others of their age, experiences and/or environment. Academically or intellectually gifted students exhibit high performance capability in intellectual areas, specific academic fields, or in both the intellectual areas and specific academic fields. Academically or intellectually gifted students require differentiated educational services beyond those ordinarily provided by the regular educational program. Outstanding abilities are present in students from all cultural groups, across all economic strata, and in all areas of human endeavor.

The measures include both nontraditional and traditional standardized measures based on current educational theory and research. ## **Differentiated Education Plan (DEP)**

Each student who is formally identified as AIG will have a Differentiated Education Plan (DEP) developed to outline their AIG service options. This plan will be created as a collaborative effort among teachers, parents, and the student. The plan will be reviewed annually.

## Gifted Program and Talent Development

Scotland County Schools adapts the core curriculum to meet the needs of our Academically and Intellectually Gifted (AIG) students. Cluster programs at the elementary and middle school level define curriculum goals that align with principles of differentiation and the North Carolina Standard Course of Study. Cluster Classes are led by an AIG certified teacher. Each school in Scotland County offers enrichment opportunities for all AIG students that may include advanced studies, project based learning, field trips, guest speakers, after school programs, clubs and social & emotional growth opportunities.
